Toda City April 1, 2025 Announcement of revision of water bill



Toda City Water and Sewage Works

[Revision of water bill] Water supply is an indispensable lifeline for the lives of citizens. To maintain a safe and secure water supply, maintenance and renewal of facilities are necessary. However, due to the increase in costs caused by soaring prices and the decrease in water supply revenue due to the expected decline in population, the financial resources will be significantly insufficient if the level of the bill set on April 1, 1996, is maintained. In principle, the waterworks business must be operated without relying on tax revenues or other transfers, as it is "self-financing," meaning that expenses are covered by the revenues from the water bill. However, the "rate recovery ratio," an indicator of the balance between the cost of water supply and the revenue from the water bill, was consistently below 100%, and it was difficult to say that sound business operations were being ensured.

Against this situation, The City Office will revise its water bill for the first time in 29 years, since fiscal 1996.

We apologize for the burden this will place on our citizens and ask for your understanding.
